uch preferable is to end the year believing that for the most part economic calamities were avoided and we now can look forward with optimism on what lies ahead.

One positive view is the apparent end to the controversy on whether the revised 20-mile, 21-station rail transit project survives after the City Council continued to keep it on a tenuous tightrope. It still requires, however, a federal clearance on its huge share of the funding, which hopefully is forthcoming.

The emerging Daniel K. Inouye Solar Telescope (DKIST) on Haleakala, pictured, hopefully will not fall victim to another protest based on a native claim of the mountain's sacredness. Labor and other proponents of the project respect people's right to raise questions but also allowance for open discussion that would result in a court review, if deemed necessary.

Organized labor tries not to take for granted that because a major project is approved it could not encounter opposition once work begins. Our inhabitants must be occasionally reminded it takes considerable planning and budgeting to ensure completion of any project.

As we close the doors on 2015, we



look ahead with our loyal Local 675 Team and industry colleagues, for a truly fulfilling 2016!



Trades Net Two Valued Project Labor Agreements

D.R. Horton, one of the nation's larger home developers, has made Hawaii the only locale provided a project labor agreement with organized labor.

"We in the building trades managed to obtain a 17-year PLA recently, Horton's action arising from our successful joint support to help the firm secure a major land use change needed by the firm to launch **Hoʻopili** as a new residential community," noted business manager **Reggie Castanares**.

Hoʻopili is a long-term joint venture with island developer James K. Schuler.

Recruitments in 2015 Yields Needed Apprentices

It was close to a record-breaker for the Plumbers apprenticeship program this year which saw 118 recruits qualified and initiated.

"Our program has been like a magnet and bodes well for the future," business manager Reggie Castanares told members at the year-end holiday celebration.

He further reported that Local 675 gained four new signatories this year.

In addition, the Union welcomed seven new journeymen.

Growth of Trust Funds on Steady Course

Business manager **Reggie Castanares**' status report on Local 675's trust funds at year-end indicated mild improvements, the total for each as follows:

Pension, \$386 million; Annuity, \$152 million; Health & Welfare, \$18 million; and Training, \$8 million.

"We expect the present economic momentum should ensure steady growth of the funds," Castanares said.

Agencies Carry Out Governor's Concerns for Labor Community

udgments and predictions may perhaps be premature at this juncture regarding the performance of a new administration that has just concluded its first year at the state's helm.

Seasoned observers will point out, nevertheless, that Governor David Ige's start is impressive, noting he is not daunted even by issues inherited before he took the oath of office. They say his experience in dealing with damage control as the former longtime head of the powerful Senate Finance Committee is attributable for his political aplomb.

Local 675 business manager Reggie Castanares seconds the assessment, noting in particular the governor's evenhandedness in considering approaches to a wide range of problems. "The Governor seems not timid or awed when faced with an unfamiliar matter for the first time," he speculated. By the same token, he is not flummoxed should a move he makes appears unpopular. An example was the choice of a prospective cabinet member rejected at the outset of his takeover. All other cabinet nominations cleared unanimously, indicating his resiliency and desire for team members he believed matched his ardor for public service and earned his trust," Castanares clarified.

To corroborate his view, the Union chief called on *Ha'aheo 675* to interview the Governor's picks for two agencies with oversight of activities that directly concern the building industry and its personnel. Their heads, coincidentally, worked on regulatory issues throughout earlier career commitments.

Our first stop, the **Department of Labor & Industrial Relations**, was a
surprise that its director, **Linda Chu Takeyama**, with an extremely diversified

background would be the first woman ever to head it.

Eight months into her current capacity, her previous ties were primarily with both public and social service agencies, most of which she headed as principal executive. Among them: staff chief for the office of Sergeant-at-Arms, US Senate; state insurance commissioner; and City department of economic development. Also a year deputy director of the State Department of Commerce and Consumer Affairs. In the private sector she remains active as chair of the Hawaii Foodbank, founder/treasurer of Hawaii 3Rs, devoted to remodel and restore public schools, and a director with the Hawaii Health Information Corporation.

She views as a key challenge actively pursuing meaningful dialogue with both businesses and the workforce, the latter generally through their union representatives. "We don't want to be regarded passive and rather want those we service that we're conscious of the importance of seeking collaboration and making

the parties subject to our regulations recognize we prefer to educate and inform," Takayama explained, referring as a recent example complaints of alleged work illegalities at the Ewa wing of the massive Ala Moana Center.

Such complaints or actual violations provide the opportunity to interact with contentious groups and move them to a positive, harmonious relationship, she explained. Labor groups insist on members to be attuned to safe work practices. The state appreciates the awareness but expects increased vigilance based on increase of accidents deriving mainly from the rise in rooftop solar contractors who need in-house safety programs.

"We're aware how quickly marketplaces change and the impact these have on the workforce," Chu Takayama said.

"Hopefully our preventative approach through use of our staff resources, including training, can do much to repel potential owner-worker disputes," she added.

Safety is also a concern for the **Department of Accounting & General Services**, a principal state source of construction work. It annually doles out hundreds of contracts, awarded mostly by either bidding or procurement.

To protect against blunders in the administering and implementing of its myriad projects, the agency carries out continuous staff training, pointed out **Douglas G. Murdock**, the state comptroller and DAGS director since Jan. l.

A career background in law and procurement, Murdock offers a combination of expertise the state could apply in light of reported shortcomings in the latter area. He previously served a three-year stint as vice president for administrative and fiscal affairs with the Hawaii Tourism Authority. Enhancing his credentials include a 25-year tie as a partner with a prominent local law group and as a certified professional contracts manager through the National Contract Management Association (NCMA). He currently serves as president of its Aloha Chapter that involves service with the State Procurement Policy Board.

When asked, Murdock replied his skill would not extend to the University of Hawaii system, which still has underlying procurement issues.

On labor's continued interest to expand project labor agreements to the public sector, the new DAGS head said there are no plans to do so. Currently it is used only on the ongoing renovation of the Kamamalu Office Building, across from Iolani Palace.

Murdock praised the work of his key functionaries, deputy director **Audrey Hidano**, who held similar roles earlier with DOLIR and the Transportation Department, and public works administrator **James Kurata**. "They have the hands-on know-how that is also appreciated by the clientele we service," he said.

PAMCA Leader Finds Own Niche in the Industry

priority for **Barry Lai** upon obtaining a UH-Manoa degree in finance management and information systems was finding an industry and company compatible with a long-term interest centered on growth shared by partner and the work force.

To his delight, he found what he sought: a business, newly organized, feeling the excitement in 2001 of an economy primed for a long run.

"The timing couldn't have been better for one in his early 20's with a firm specializing in sheetmetal and air condition work," Lai recalls.

More propitious were the training programs, in particular, the one signatories partnered with the **Plumbers & Fitters Local Union 675**, he explained. "I noticed in my early years with the trades that those who successfully completed its vigorous five-year apprenticeship have proven over the years as standouts," he added. "That makes the difference in the quality of the workmanship customers rave about."

Just 41, Lai is the youngest tapped by industry colleagues to head the **Plumbing and Mechanical Contractors Association** over the next two years. "Again, it was good timing though I've been in the business some 14 years, first Air Controls Inc., and in recent years, as vice president of Air Central, Inc.," he said. The latter is headed by **Greg Kiyan**, who oversees the presidential duties.

The business is at 1717 Colburn Street in a Kalihi neighborhood filled with small to medium trade specialty shops. "We like its central location given how Oahu has developed to such an extent that more businesses have to operate in distant locales outside the city," he noted.

Air Central has some 20 active refrigeration mechanics and 25 sheet metal workers. Lai himself also serves on the Sheetmetal Contractors Association board. "What I truly enjoy is the time spent with the **Joint PAMCA-Local 675 Apprenticeship Committee**. There one can proudly see what recent upgrades in enrolling prospective tradesmen has meant for consumers in quality work, and for that we're thankful **Reggie Castanares** and his apprenticeship training team are unquestionably great models," he enthused.

Another critical joint effort with the Union is PAMCA's support of raising code standards.

Lai said the Union has taken various initiatives in other concerns that PAMCA shares. "Legislation is always something we join hands in, supplemented by our ties with the **Subcontractors Association of Hawaii**. It continues to resist efforts by general contractor organizations to be allowed to be licensed in various specialty contracting areas. That would harm tried and true subcontractors," he said.
