The ballots were counted on December 9th with results posted on the Union's website (see page 2 for final officers' certification). The officers and board members were elected into office for three-year terms. Elected officers and board members were sworn in on January 3, 2022 at the regular in-person General Membership Meeting at Ke'ehi Lagoon Memorial – Veterans Hall.

All the officers who attended the meeting and were sworn in were fully vaccinated.

Happy holidays to all as we welcome in a brand new year and new beginnings. Despite another trying year, I hope that everyone was able to enjoy their holidays and remain healthy and safe.

I would like to thank all the members of Local 675 who

participated in the Union's first-ever mail-in ballot officers election. Members who would not have had the means to vote in person especially during the pandemic were able to cast their vote by mail ballot. I appreciate the confidence and support instilled in me along with my fellow officers to continue serving the membership of Local 675.

We have proudly accomplished a lot in the three years of my first term and I would like to highlight and summarize some of them as Business Manager/Financial Secretary-Treasurer. Going back to 2019 when I first took office:

- Initiated Forensic and Financial audits and implemented new policies and procedures according to UA guidelines.
- Hired on contract, a new labor attorney **Herbert Takahashi**, Attorney-At-Law.
- Hired on contract, a new certified public accountant Lemke, Chinen and Tanaka, CPA, Inc.
- Hired a Government and Community Relations Director - Kika Bukoski.
- Initiated closure of the Pacific Equity Group, an entity operating at a loss.
- Improved communications and transparency by bringing back the Union's newsletter and updated website.
- Streamlined the dispatching procedures for more efficiency and updated computers and operating programs.
- Mandated and provided license holders for our Union journeyman plumbers.
- Met with and established government, political, union, management, and developer relationships.
- Managed and wrapped up the **Huhonua** industrial bio-energy project employing 170

Local 675 and travel card members.

- Maintained integrity of the Uniform Plumbing Code via the 2012 Kauai County Plumbing Code, Bill 2612 adopted into law.
- Oversaw the special 100th Year Anniversary program with General President **Mark McManus** as the Honorary Chairman.
- Implemented safety procedures and supplied safety items for the on-going Covid-19 pandemic.
- Signed 10 new signatory contractors before and during the pandemic.
- Signed 3 Project Labor Agreements including the 20-year **Kamehameha Schools** contract.
- Negotiated a Labor/Management Agreement contract with a 5-year unprecedented \$12.25 or 16% wage and benefit increase.
- Brought back the current Pension Benefit Unit rate \$100 during the pandemic.
- Increased money coming into the Pension Fund by re-allocating .97 cents per hour to the Pension Fund from the Cooperation, Training and Operating Funds. This includes the lowered .50 cents work dues toward the Pension Fund.
- Negotiated an additional .50 cents from the contractors toward the members' Annuity Fund.
- Established an online year-round apprenticeship recruitment program.
- Oversaw the 40th UA Convention with first-ever delegate nominations and mail-in ballot voting. Appointed to the UA Credentials Committee.
- Implemented Officer Election with first-ever nomination and mail-in ballot, enabling a voice for all Local 675 members.

I would like to emphasize one of the biggest changes that stands out besides the unprecedented 16% wage and benefit increase and stabilizing the Pension Fund, was the accomplishment of receiving an executive order from UA General President **Mark McManus** for approval to have mail-in ballots for the Local 675 Officers Election. This immediately gave neighbor island members, including out-of-state retirees, and others, an opportunity to cast their vote, a record for Local 675.

These were some of the main goals we as officers strived for in the very beginning and accomplished (continued on page 4)

Aaron Stockwell – International Representative for California and Hawaii



Aaron Stockwell was elected unanimously to the position of International Representative at the 40th General Convention in August 2021. He will be responsible for the territories of California and Hawaii protecting the interests of members

who work in the two states. In 2020, before his election as International Representative, Brother Stockwell was elected as the Executive Director of the California State Pipe Trades Council. He had been the Business Manager/Financial Secretary of Plumbers and Pipefitters Local 447 in Sacramento, CA, since 2016, after serving one year as Business Agent after being elected in 2015. Brother Stockwell was elected to the position of Vice President of Local 447 in 2012. In 2014, he was appointed as an Organizer for the local. He has served as a Trustee for Local 447, Health and Welfare, Pension Trust Funds, and the Joint Apprenticeship Committee. He also served as Vice President of the Sacramento-Sierra Building Trades Council and as an Executive Board member of the California State Pipe Trades Council. Brother Stockwell was initiated into Plumbers and Pipefitters Local 447 in 1992. After completing his apprenticeship, he worked on various public and private commercial projects across the Northern California region.

Herbert S.K.Kaopua, Sr. Remembered

The Plumbers and Fitters UA Local 675 'ohana recently learned of the passing of one of its transformative and visionary leaders beloved and respected by many, **Herbert S.K. "Chubby" Kaopua, Sr.**

The son of long-time Local 675 leader Isaac "Ike" Kaopua, Chubby worked his way through the ranks to become the Union's third and second longest tenured leader in its nearly fifty years of the existence at the time. "A young, up-and-coming guy who could learn the ropes." Legendary leader and pioneer of Local 675, Ed Kovack mentioned to Isaac "Ike" Kaopua, Sr., that he had his eye on a potential new leader.

After 17 years in the field, Chubby began his journey serving on the Union staff as a Business Field Representative, absorbing everything he could. Chubby became an Executive Board member in 1981 and assumed the position of Local 675's new Vice President. In 1985 he became Assistant Business Manager under the mentorship of **Ed Hashimoto**.

Chubby directed key Local 675 investment decisions during the late 1980's and early 90's. One such decision was the purchase of the Bethel Street building in which the Union Office is currently situated, now called the Plumbers and Fitters UA Local 675 Building. He was also able to finalize Ed Hashimoto's vision of an established Federal Credit Union to provide for the financial needs of the union members.

In 1990, **Ed Hashimoto** officially retired and Chubby, assumed the position of Business Manager and Financial Secretary-Treasurer of Local 675 until his official election in 1992.

Committed to promoting the welfare and stability of the industry, Chubby was widely recognized as a leader among union leaders. His deep involvement with union and community organizations was demonstrated by the expanding role Local 675 played in shaping Hawaii's community. Chubby was instrumental in leading the Union to a strategic position for managing dynamic change. He formulated a master plan designed to successfully move Local 675 into the next century. One big step was establishing strong staff support by utilization of specialists in key areas – legal, legislative lobbying, government affairs, and marketing.

One such example was the participation and investment in the 5,500 unit Soda Creek development in Ewa through the Hawaii Development Foundation (HDF). Chubby was a driving force in creating HDF, which pooled labor and management resources as a means of securing union jobs for union members.

Some of the positions Chubby served in during his tenure include: President of the Hawaii Building & Construction Trades Council, Co-Chair of the Hawaii Construction Industry Association (HCIA), President of the Plumbers & Fitters Federal Credit Union, Hawaii State Apprenticeship Advisory Board Member appointed by Governor Waihee, Chairman of the Hawaii Building & Construction Trades Council, Educational & Charitable Foundation, later to be called the Hawaii Union Builders (HUB) Foundation, Chairman of the International Association of Plumbers and Mechanical Officials (IAPMO), Hawaii Chapter, Board Member of the Honolulu Board of Water Supply.

A longtime friend and retired member of Local 460 out of Bakersfield, California, **Daniel "Danny" Nunez** reminisced how his close friendship of nearly fifty years with Chubby endured throughout the years. Nunez recalls fond memories of meeting Chubby for the first time in 1974 when he first arrived in Hawai`i as a traveler, and how Chubby took him in as family and taught him what the true meaning of "Aloha" was. The last time Nunez spoke to Chubby was on December 12th of this year, Chubby's birthday...

This friendship that grew out of "Aloha" exemplifies who Chubby was and the example he set for the Local 675 family he nurtured and cared for deeply. Whether near or far, we are all one 'ohana. Our heartfelt and deepest sympathy goes out to the Kaopua `ohana. Chubby will surely be missed.

Dues Payment Reminder

As a reminder, member's monthly dues shall be payable by the first of each month. You must pay your monthly dues in order to maintain membership in Local 675 and the United Association (UA). Failure to pay the monthly dues will result in a Suspension and an eventual Expulsion from the Local. The rules for suspension and expulsion from membership for non-payment of dues are set forth in the UA Constitution. SEC. 156 states, "A member owing over three (3) months' dues shall automatically be suspended from membership without notice of any kind..." SEC. 157(a) states, "A suspended member becomes in good standing and his suspension is lifted by the payment of all back dues through the current months together with a \$50.00 reinstatement fee..."
